## **Privacy Collection Notice**

To enable us to provide effective and appropriate services to all our clients, Big Yellow Umbrella needs to collect some basic personal information about you, which may include name, contact information, age, gender, and Indigenous status, as well as information on the issues and concerns you are seeking to address.

This information – "client data" – is stored on a secure and sophisticated computer-based client management data system. Access to this information is restricted to authorised persons only.

Your consent is needed to store your information. You also need to be aware that Big Yellow Umbrella uses software providers such as Smartsheet and Mailchimp. Your email address and first name only will be stored on their servers which are in the United States. Your involvement in providing this information is completely voluntary and you may withdraw your consent at any time.

Big Yellow Umbrella receives funding from local, State, and Commonwealth Governments and other non-government sources. As part of their funding, we are required to provide them with general information about people using our services. This will be used for reports, grant administration, research, and evaluation. Funding bodies cannot identify you as no identifying information such as your name is provided.
